

END USER LICENSE

READ CAREFULLY: THIS END USER LICENSE (THE "AGREEMENT") IS A CONTRACT CONCLUDED BETWEEN YOU (the "Licensee" or "Customer") AND FEELIGREEN OR ITS AFFILIATES OR DISTRIBUTORS (hereinafter "the Editor"), regarding the FEELIGOLD application, developed by the Editor, in object code, including all associated documentation (the "Application"). This License also applies to all corrections, enhancements and updates to the Application that would be provided by the Publisher unless the Publisher links these to a new license. BY ACCEPTING, INSTALLING, COPYING OR ANY OTHER USE OF THE APPLICATION, LICENSEE AGREES TO ADHERE TO THE TERMS AND CONDITIONS OF THIS LICENSE.

HOWEVER, IN CASE A WRITTEN AGREEMENT FOR THE USE OF THE APPLICATION WAS CONCLUDED BETWEEN THE PARTIES, THE LATTER WILL PREVAIL ON THE PRESENCE LICENSE.

1 DEFINITIONS

The terms defined below, whether used in their singular or plural form, have in this License, the following meanings:

- **Application:** refers to all computer programs in object code (including its Updates) downloadable from the Site and relating to the application "FEELIGOLD" developed and implemented by the Publisher and that the Customer can download from mobile software distribution platforms;
- **Assistance:** refers to all benefits provided by the Publisher to Customer, consisting of consultation and assistance via email.
- **Online Shop:** refers to the commercial part of the Site, from which the publisher offers its products for sale and where the Customer can order and be redirected to a mobile software distribution platform where to download the Application;
- **Terms and Conditions of Use (hereinafter the "Terms"):** refers to all the terms and conditions under which the Publisher makes the Site available to the Customer and enables the use;
- **Malfunction:** refers to a malfunction of the application that prevents operation in accordance with the documentation accompanying the application.
- **Customer Environment:** refers to a set consisting of the hardware and software (operating system, database, database management system,...) of the Customer .
- **Days or Hours of operation:** refers to the days and hours between 9:00am and 5:00pm Monday through Friday, excluding holidays.
- **Law:** refers to all the laws, statutes, ordinances, codes, regulations and other decisions emanating from a government authority.
- **Maintenance:** corresponds to the services including Corrective and Evolutionary Maintenance of the Application:
 - **Corrective Maintenance:** any intervention to detect, correct or possibly bypass the Failures reported by the Customer;
 - **Evolutionary Maintenance:** services consisting of the delivery of Updates of the Customer Application;
- **Update:** refers to the successive versions of the application with either correction of malfunction or abnormalities, or technical and / or functionality improvements, provided by the Publisher. The Updates include any change to the application to bring it into conformity with respect to regulatory and technology new requirements. They do not necessarily include new functionality of the Application which can be marketed independently by the Publisher, but should include all changes and functionality defined by the Publisher. Each Update including technical and / or functionality improvements is identified by a version number (eg Version 4.3 or 5.0).
- **Site:** refers to the Internet Site in the URL <http://www.feeligold.com>;
- **Download:** refers to any action by the Customer to load the Application, available on mobile software distribution platforms accessible via a link on the online store of the Site, to use it on a terminal, smartphone or tablet, in accordance with the provisions of this License;
- **Territory:** refers to all countries worldwide.

2 SCOPE OF LICENSE

1 Rights conceded

The Publisher grants to the Licensee, who accepts, a nonexclusive, nontransferable license to integrate and use the Application for the Territory and in strict accordance to the Usage Domain defined below.

The Customer expressly acknowledges that all rights to trademarks, know-how and technical concepts as well as the rights attached to the Application remain the exclusive property of the Publisher.

2 Usage Domain

This license is expressly limited by the Parties to the acts necessary to download, install and use the Application in the Licensee's Environment.

Licensee must download, install and use the Application for its own use.

3 Limitations

The Customer is not authorized by the Publisher to do the following:

- Reverse engineering, disassembly or decompilation of the application, with the exception of what is expressly authorized by the applicable law,
- remove identification and copyright or brand markings from the Application,
- sell, rent, loan or use the Application in order to share it,
- use or copy the application in any other manner non expressly authorized by the parties.

Licensee wishing to use the Application for any purpose other than that provided for under this License must request authorization in writing to the Editor who reserves the right to accept or reject in its sole discretion.

3 INTELLECTUAL PROPERTY

All industrial property rights and copyright in the Application (including but not limited to any trademarks, images, photographs, animations, videos, audio, graphics, music, text and other IP integrated into the Application), are the property of the Publisher. The latter owns and retains rights on each copy the Application.

Thus, the Licensee shall not reproduce or modify the Application for a purpose other than backup, and provided that all rights and terms are reproduced and included in the backup.

The Application is protected by the laws and international treaties on intellectual property and copyright. Accordingly, the holder is obliged to treat the Application as any other protected material, unless otherwise authorized under this License.

This License bestows no right of ownership to the Licensee on the Application.

4 PERSONAL DONNEES

According to the Law of January 6, 1978, the collection and computer treatment of personal data that can possibly be performed by the Application have been previously reported to the National Commission for Computing and Liberties under the number: **1558933**. Anyone can access it by writing to the CNIL, 21 rue Saint Guillaume, 75340 Paris Cedex 07, or e-mail decweb@cnil.fr.

These data will be collected by the Editor to record any use of the application made by the Customer and will be used to process orders, if any, and to inform the Customer about Publisher's offers (newsletters, emails, ...).

The operation of the Application may involve the collection of a number of personal data from customers. This collection's main purpose is to guarantee the proper function of the Application and the establishment of general statistics on the type of care performed by the customer and the type of errors encountered during use of the Application. The collection of certain personal data can be made by the Application on the Customer terminal to facilitate navigation in the application, to establish general static data on the consumption of products of the Publisher by Customers. Although they do not allow direct identification of the user they are assimilated by the CNIL to personal data. The information collected will not be disclosed or sold to third parties except for legal requirements corresponding to mandatory disclosure to judicial authorities.

A fortiori the Publisher shall not make any transfer of personal data that may be collected via the application, to non-customers of the European Union countries that do not have a level of protection equivalent to that in force in the Union. In the unlikely event where such a transfer would be necessary and planned, the Editor would agree to sign a prior agreement with the data receiving party, under which the latter would undertake to provide a data protection in accordance with Directive 95/46 / EC of 24 October 1995, transposed into French law by the Law of 15 July 2004 and to communicate this agreement to the CNIL.

According to Article 39 of Law No. 78-17 of 6 January 1978 on computers, files and freedoms, as amended by Act No. 2004-801 of 6 August 2004 (Article 5) the Customer has a right to access, modify, rectify and delete personal data. Applications are processed within a minimum delay of fifteen days and not more than one month.

5 CONFIDENTIALITY

Licensee acknowledges that he is subject to an obligation of confidentiality that applies to the Application and to this License. Therefore, the Licensee shall, during the term of the License, ensure the confidentiality of all information provided by the Editor, and shall not disclose any confidential information to a third party without the prior written consent of the Publisher.

6 TERMINATION

This License will terminate automatically in the event of failure by the Licensee to any of its obligations. Upon termination, all rights granted on the Application shall cease immediately and the Licensee shall, at its own expense and without delay, destroy or return to the Publisher all copies of the Application and related documentation.

The provisions of this License on guarantees, limitations of liability, damage or intellectual property rights of the Publisher survive the early termination of the License.

7 TRANSFER RIGHTS

Licensee may not assign, give or transfer any rights or obligations he holds under this License without the prior written consent of the Publisher. Any transfer made in violation of the foregoing shall be null and void and will be likely to constitute an act of infringement to the detriment of the Publisher.

8 APPLICABLE LAW - JURISDICTION

This license is subject to French law. It is written in French. In case of translation of this End User License in several languages, only the French version shall prevail.

In case of dispute arising from the interpretation or execution of this License, the Parties undertake to seek an amicable solution.

In the absence of such a solution within thirty (30) days from the date of occurrence of the dispute, the dispute shall be the sole responsibility of materially competent court within the jurisdiction of the headquarters of the Editor, whether or not there are multiple defendants or in case of an appeal, even under emergency or conservatory procedures.
